



Programme Low Carbon Technologies - Electromobility - Call V

The programme aims to support competitiveness of enterprises and sustainability of the Czech economy by introducing innovative technologies in the field of electromobility. To increase the use of more effective and more reliable low-carbon technologies that are not yet common in the Czech Republic.

SCHEDULE

Receipt of applications for support:

• 06. 01. 2020 - 28. 05. 2020

SUPPORTED ACTIVITIES

- introduction of innovative technologies in the field of low-carbon transport electromobility of road vehicles.
- purchase of an electric vehicle supported categories of road vehicles:
 - L (motorcycles, quadricycles)
 - M1 (passenger cars)
 - o M2 and M3 up to 7.5t (minibuses)
 - N1 and N2 up to 12t (lorries)
- BEV battery electric vehicles
- EREV extended range electric vehicles
- purchase of non-public (rapid) charging stations within the business premises for own needs for electric vehicles, the charging station may be extended with a battery and a photovoltaic installation (PI), provided that the battery and the PI is a part of the charging station

APPLICANT

As of the date of the application, the grant applicant/beneficiary must meet the following conditions:

- The applicant/ beneficiary may be a business entity; a small and medium-sized enterprise according to the definition in Annex I to Commission Regulation (EU) No 651/2014, or a large enterprise that keeps accounts or tax records expanded with special requirements, or must keep separate accounts for the project
- is authorised to conduct business corresponding to the supported economic activity which is to be carried out through the project;

- is, based on its sworn declaration, registered as an income tax payer in any of the EU member states and has been so continuously for at least two closed tax periods preceding the date of submitting the application; the applicant notes that it will have to have an establishment or a branch established in the Czech Republic at the moment of receiving the support;
- is not, based on its sworn declaration, in arrears to selected institutions in the country of its registration, or in the country where its branch is registered, and to providers of support from projects co-financed from the EU budget;
- It does not have any outstanding liabilities, according to its sworn declaration, based on its employees' wage and salary claims.

SECTORAL DEFINITION

- The aid shall support projects with outputs affecting the sectors defined in Annex 1 to the Call.
- The aid shall not be provided to projects with outputs directly affecting any of the sectors defined in Annex 1 to this Call.
 - production, processing and marketing of products listed in part B of the Annex to this Call,
 - agriculture, forestry, fishing, aquaculture (CZ-NACE A 01, A 02, A03);

KEY CONDITIONS OF THE CALL

- The project must be implemented in the Czech Republic outside NUTS II Prague.
- The applicant must clearly demonstrate ownership or other rights to buildings and land plots, where the project will be implemented.
- The project must include all mandatory elements listed in the Call for submission.
- The project does not expect any aid for activities linked to the quantities exported (export subsidies), aid for the establishment and operation of a distribution network abroad or for other current expenditure linked to the export activity (customs duties, insurance, etc.) or any aid contingent upon the use of domestic goods instead of imported goods.
- The project has not started before the date of filing the application.
- The project must not violate the EU horizontal policies and their basic principles such as equal opportunities (equality of men and women, removing discrimination based on sex, race, ethnic origin, religious belief, world view, disability, age or sexual orientation), equal opportunities and non-discrimination (e.g. due to social exclusion or health environment) and sustainable development (observing the EU and national regulations concerning environmental protection).
- The financial health of the applicant, expressed in a simplified economic assessment of the intermediate body, must not be lower than 5 points.
- Projects with total eligible expenditure at and over CZK 5 million and at the same time with investment expenditure that forms more than 50% of the total eligible expenditure will be required to carry out a Financial Analysis of the investment.

ELIGIBLE EXPENDITURE

- Tangible fixed assets
- Intangible fixed assets (if required for due operation of the tangible fixed assets)



FORM AND AMOUNT OF AID

- The minimum grant provided for a project is CZK 250 thousand and the maximum grant shall not exceed the de minimis aid ceilings.
- Aid intensity for the vehicle category M1
 - o If the beneficiary is a small enterprise, the support is provided up to 30% of EE.
 - o If the beneficiary is a medium-sized enterprise, the support is provided up to 25% of EE.
 - o If the beneficiary is a large enterprise, the support is provided up to 20% of EE.
- Aid intensity for the vehicle categories L, M2, M3, N1, N2
 - o If the beneficiary is a small enterprise, the support is provided up to 40% of EE.
 - o If the beneficiary is a medium-sized enterprise, the support is provided up to 35% of EE.
 - o If the beneficiary is a large enterprise, the support is provided up to 30% of EE.

If the applicant intends to purchase a vehicle (vehicles) of the M1 category and at the same time a vehicle (vehicles) of the L, M2, M3, N1, N2 categories, it must submit two separate grant applications.
